Commercial Pesticide Applicators are licensed by the State of Colorado and not by San Miguel County. Although this list is compiled by San Miguel County, the County does not endorse or recommend the work performed by any particular listed vendor. Information was provided by the vendors and was not independently verified by San Miguel County. Prices and services may vary widely from vendor to vendor and the wise consumer is advised to compare prices, products and services.

In addition to licensure each individual providing service is certified in specific categories. The license categories are listed. No applicator may make any application in any category for which no certification is held. This list is updated annually and new categories may have been added without the knowledge of San Miguel County.

It is unlawful in Colorado for any person or company not registered as such to make applications of any pesticide- restricted use or general use- and charge for such application.

No individual holding an EPA pesticide applicators card can make applications and charge for such applications- charging includes pay for services, barter and other exchanges of goods or money.

Pesticides is a broad category including herbicides, insecticides, fungicides, rodenticides, wood preservatives and other products designed to prevent, destroy or kill any pest.
